and/or our testimonies, and creating a social media presence.

Care Coordinating Committee 2017 Year-end Report

In 2017 the Care Coordinating Committee continued its work coordinating care for the Herndon Friends community in times of need.

The Circle of Care continues with 52 Friends who are willing to consider offering their services for specific tasks such as providing rides, meals, and child care, based on what assistance is needed and whether they are available to provide it. This system is most often used to assist Friends undergoing or recovering from surgery, and in 2017 three Friends and their families were assisted for that purpose. Due to continued technical difficulties, the Committee changed the web-based organizing platform used to keep track of assistance needs and offers of help. Under the care of M&O, the Committee also provided Circle of Care members the opportunity to re-subscribe to the distribution list or opt-out, depending on their current level of interest or capacity to provide help.

Care Committees continue to play an important role. One new committee was established in 2017 and another continues its ongoing work. Both Care Committees worked to help families facing difficult health challenges.

Communications Liaison remains an important function. At times, there are needs that can only be met with prayer, friendship, and encouragement. The Care Coordinating Committee stands ready to communicate these needs to the wider community, while monitoring for material or spiritual needs that might be met by the Circle of Care or a Care Committee. The names and email addresses for each of the Care Coordinating Committee members appear on the front page of The Herndon Light, and Friends are encouraged to reach out.
