worship to identify candidates for an Ad Hoc Nominating Committee to identify one to two candidates for the nominating committee. Responding out of the silence Don Chamlee and Katherine Cole volunteered to serve as the ad hoc committee. Their service was accepted.

Committee on Greening the Meeting House Margaret Fisher presented two proposals from the Greening Committee:

To encourage reuse of paper materials, Greening committee has proposed the meeting hold a periodic event to share magazines or books of spiritual nature. If accepted, the expectation is that materials would be brought into the Meetinghouse on a specific day, possibly the day of Adult Discussion sessions. Friends could take what materials they wanted, with the expectation that the person who brought them in would take home any unwanted materials that day. The proposal was accepted.

The Committee also recommended the creation of a "yahoo group" to post availability of useful but rarely needed equipment (think leaf blowers or shredders, party supplies like punch bowls or folding chairs, baby strollers for visiting nieces and nephews or garden equipment.) This would mainly be for borrowing but could be used to offer items to give away. The list could be expanded to include services like ride sharing, or babysitting. Unlike services such as Freecycle, the listings would only be available to Herndon Friends and access would be by invitation only. The proposal was accepted as a trial. Treasurer Devon Mahoney presented the second reading of the 2016 Budget. An excerpt is presented below

It was noted that total contributions declined from \$49,700 to \$47,900. Some of this deficit is thought to be related to incomplete reporting of "In-Kind" contributions (IE: someone purchases sandwich supplies and decides not to ask for reimbursement so doesn't give Devon the receipt).

Due to recent drops in stock market, The Growth and Building Fund showed minimal growth despite the addition of the \$5000 payment from Dominion Electric for the easement to place the electrical box on the corner of the meetinghouse lot. The Finance Committee continues to monitor HFM investments.

BYM apportionment represents the second largest expenditure in the budget, after the mortgage. The apportionment is the amount requested from BYM to support the administrative activities of the yearly meeting. The apportionment is set by the BYM finance committee and is based on a formula that includes the number of members, and the contributions received by monthly meetings. Forty two monthly meetings are assessed by BYM a total of 462, 200 resulting in a mean of 11,005, with apportionment ranging from \$570 (at Gettysburg Monthly Meeting) to \$65,000 for Friends Meeting of Washington. At \$10,410, Herndon Friends Meeting is the 13th largest contributor. Some meetings have not been able to fund their allotted apportionment amount, and BYM has a 2-3% non payment rate; this year they've budgeted for a \$6500 "bad debt" on apportionment. In the last two years, Herndon Friends Apportionment has actually decreased, but the Meeting has decided to continue to send the difference between the 2014 assessment and the current assessment as an unrestricted donation. Some other meetings are doing the same

Report of the Greening Committee

We have been discussing ways to reduce the storm water runoff from our property. Runoff from impervious surfaces is a major contributor to the degradation of our waterways and destroying the things that live in them. Normally in Virginia, most rain water would be captured and percolated by trees and other plantings and arrive in streams gradually from underground. Now, though, it rushes off roofs and pavements and dumps quickly into streams, causing them to flood. The flood water undermines the stream banks, kills the stream life, and carries sediment down to the bay where is smothers the aquatic grasses which are the basis for that ecosystem. Runoff also carries poisons with it. The best solution to this problem is for landowners to take responsibility for retaining storm water on their own properties. There are a variety of ways to do this technically, including building underground water collectors and rain gardens. The majority of our property is covered by impervious surfaces. The meeting will need to decide whether it is willing to spend money to help the rest of the living world, knowing that there will be no monetary return on the investment.

We have consulted Dan Schwartz, from the Northern Virginia Soil and Water Conservation District, and we have asked for an estimate from Ken Fraine, owner of Drainage and Erosion Solutions. We plan to discuss it again at the next Greening Committee meeting, which is planned for 9 am on February 7. All are welcome. --Margaret Fisher

Ministry and Oversight Committee Year-End Report 2015

The Ministry and Oversight Committee continued our work in 2015 to support the spiritual life of the Meeting. Early in the year, we held adult discussions on the testimonies of Peace and Simplicity, as well as the Godly Play story of Easter. The Spiritual State of the Meeting was discerned through Worship Sharing. Mid-week Meeting for Worship was provided, but not well-attended, which has led the committee to lay this down for next year. In lieu of a full retreat this year, we had an all-ages game night that was well attended and hope to continue to have more of these in the future.

At the request of Baltimore Yearly Meeting, we encouraged the Meeting to review sections of Faith and Practice and submitted feedback.

In May, Fauquier Friends Worship Group, which is under the care of Herndon Friends Meeting, celebrated its one year anniversary.

During the summer, the discussion about our connection with food and living in unity with the world led to a minute approved at Meeting for Business. Six children from our Meeting attended Baltimore Yearly Meeting Camps, and their families received our camp grants.

In the fall, we asked each committee to lead an adult discussion relating to their work. Religious Education began with thought-provoking fables. The Nominating Committee led a discussion where each committee was represented to speak about the work they do. The Greening Committee facilitated a discussion led by a representative from Alliance Climate Solutions. We are looking forward to continuing with the remainder of the committees next year.

This year we welcomed new member Jodi Beatty and the transfer of member Inga Erickson. We also celebrated the marriage of Caitlin Murphy and Damian Allen. Four members went through the process to officially be able to sign Virginia marriage licenses, and we are looking forward to future marriages under the care of HFM.

The Care Coordinating Committee, which will have its own year-end report, provided support for a variety of members and attenders in need.

Sadly, Dee Dee Wilkins missed the first Business Meeting of 2016, breaking her lifetime streak of attendance. Herndon Friends believe so strongly in the value of Quaker camp for our young Friends that we offer \$350 scholarship assistance to every child in the meeting to help defray the cost of attending a BYM camp.

Catoctin Quaker Camp is building a new bathhouse. BYM is still soliciting donations to cover the cost—so far \$188,00 has been received towards the goal of \$297,000.

The Washington Friends Conference on Religion and Psychology is hosting their annual retreat on February 12-14 at the Bishop Clagett Center near Frederick Maryland.
